JUDGE HOGAN CALLED THE SPECIAL MEETING TO ORDER AT 3:00 P.M.

BOB BASS OF ALLISON, BASS & ASSOCIATES, L.L.P. EXPLAINED TO THE COURT THE HISTORY, CONCEPTS, PRINCIPLES, LEGAL STANDARDS AND THE PROCESS OF REDISTRICTING OF COUNTY POLITICAL BOUNDARIES. MR. BASS ALSO GAVE AN EXPLANATION OF THE COUNTY'S OBLIGATIONS, SHOWED WORKABLE ILLUSTRATIONS AND DISCUSSED HOW TO START THE PROCESS.

THE MOTION WAS MADE BY COMMISSIONER MAGNESS, SECONDED BY COMMISSIONER WIMPEE WITH THE COURT VOTING 5-0 IN FAVOR OF MOVING FORWARD WITH THE REDISTRICTING OF POLITICAL BOUNDARIES. CRITERIA FOR REDISTRICTING OF COUNTY POLITICAL BOUNDARIES AS PRESENTED AND LET IT BE NOTED THAT POINTS ONE THRU ELEVEN ARE LISTED NOT IN ORDER OF PRIORITY BUT ARE INDEPENDENTLY IMPORTANT. JUDGE HOGAN REITERATED THE NEXT STEPS TO BE TAKEN TO START THE PROCESS.
