LISA CONSTANT, COUNTY CLERK REPORTED THE LATEST INFORMATION ON THE REDACTION ISSUES FACING THE CLERK'S OFFICE. KAY MCDANIEL-DISTRICT CLERK ALSO SPOKE ABOUT REDACTION ISSUES AND THE LARGE NUMBER OF APPLICANTS COMING TO HER OFFICE FOR PASSPORTS AND ITS EFFECT ON HER OFFICE.
