JOHN BLACKWOOD, COUNTY AUDITOR EXPLAINED TO THE COURT THE
CURRENT PROCEDURE FOR FUELING ROCKWALL COUNTY VEHICLES BY
WHICH THE COUNTY USES THE CITY OF ROCKWALL'S FUEL PUMPS AND
THEN THE CITY SENDS THE COUNTY AN INVOICE. THE CITY PLANS TO
SHUT DOWN THESE PUMPS SOON AND THE COUNTY NEEDS AN
ALTERNATIVE SOLUTION. THE AUDITOR DETERMINED THAT THE STATE
FUEL CARD HAS A LOWER COST PER GALLON OF GAS THAN WE ARE
CURRENTLY BEING CHARGED. THE STATE FUEL CARD CAN BE USED AT
ANY SERVICE STATION IN THE STATE OF TEXAS AND THERE WILL BE A
MONTHLY BILL. HOWEVER, THE CARD CANNOT BE USED FOR OFF –
ROAD VEHICLES. THE ROAD AND BRIDGE DEPARTMENT HAS ITS OWN
