- **DISCUSSION OF ABANDONMENT OF ROAD RIGHT-AWAY IN SUNRISE BEACH SUBDIVISION:** TREY TAYLOR, A POTENTIAL PURCHASER OF LOT 14, CAME ACROSS A PROBLEM AND CONTACTED COMMISSIONER WIMPEE REGARDING THE ISSUE TO ABANDON THE UNUSED PORTION OF HIGH NOON DRIVE (30' X 100'), LOCATED IN THE SUBDIVISION OF SUNRISE BEACH ESTATES. THE UNUSED PORTION HAS BEEN USED AND MAINTAINED BY THE PREVIOUS OWNER OF LOT 14 FOR AT LEAST 15 YEARS AND THE OWNER OF LOTS 48 AND 49 HAS AGREED TO THE ABANDONMENT OF A PORTION OF HIGH NOON DRIVE TO THE OWNER OF LOT 14. TREY TAYLOR WILL MEET WITH LISA CONSTANT, COUNTY CLERK TO REVIEW THE PROPERTY

- **DISCUSSION OF COUNTY ROAD BOND ISSUES:** THE COURT DISCUSSED WITH JOHN POLSTER OF ITS, ROCKWALL COUNTY'S ROAD CONSULTANT, THE NEED FOR A ROAD BOND PACKAGE AND HIS RECOMMENDATIONS. THE COURT IS RESPONSIBLE FOR THE GENERAL HEALTH AND SAFETY OF OUR CITIZENS. THE FUNDS WILL BE DIRECTED TOWARD ROADS THAT CARRY THE MAJORITY OF THE TRAFFIC IN OUR COUNTY. THE BOND PACKAGE ISSUE WILL BE ADDRESSED TODAY WHEN THE COURT RETURNS TO THE RECESSED REGULAR MEETING FOLLOWING THIS WORKSHOP. THE COURT FURTHER STATED THE IMPORTANCE OF BEING REPRESENTED ON THE REGIONAL TRANSPORTATION COUNCIL.
- **DISCUSSION OF TRANSFERRING THE RESPONSIBILITY FOR THE PHONE SYSTEM TO THE COUNTY IT DEPARTMENT:** A RECOMMENDATION FROM THE NEW TELEPHONE SYSTEM CONSULTANT IS TO TRANSFER THE RESPONSIBILITY OF THE PHONE SYSTEM FROM THE AUDITOR'S OFFICE TO THE IT (TECHNOLOGY) DEPARTMENT. BRIAN CRENSHAW, IT DIRECTOR, REQUESTED A NEW POSITION IN HIS DEPARTMENT TO ACCOMPLISH THE INCREASED WORKLOAD IN HIS DEPARTMENT. THIS ITEM WILL BE ADDRESSED TODAY WHEN THE COURT RETURNS TO THE RECESSED REGULAR MEETING FOLLOWING THIS WORKSHOP.
