- DISCUSSION OF GOVERNMENT CENTER DRIVEWAY: THE ROAD BETWEEN O'REILLY'S AUTOPARTS AND THE GOVERNMENT CENTER WILL NEED TO REPAIRED AND REPAVED. A PORTION OF THE REPAIR/REPAVING WILL BE THE COUNTY'S RESPONSIBILITY. THE PARKING LOT OF THE GOVERNMENT CENTER COULD BE REPAIRED AT THE SAME TIME. ESTIMATED COSTS WILL BE RESEARCHED.
- DISCUSSION OF A NEW COUNTY WEBSITE: BRIAN CRENSHAW RECOMMENDED HIRING OUT THE TASK TO A WEB DESIGNER. HE WILL BRING BACK TO THE COURT SOME IDEAS.

- DISCUSSION OF ADOPTION OF REVISED COUNTY THOROUGHFARE PLAN: SHOULD THE COUNTY ADOPT A REVISED THOROUGHFARE PLAN AND WHAT ARE THE NECESSARY STEPS/GUIDELINES TO APPROVE A REVISED PLAN.
- DISCUSSION OF TRANSPORTATION CONSORTIUM'S SCOPE OF WORK: SHOULD THE CONSORTIUM BE DISSOLVED.
- DISCUSSION OF COUNTY FIRE CODE: FIRE MARSHAL WILL BRING BACK TO A REGULAR MEETING AND WILL REMOVE ALL REFERENCE TO RESIDENTIAL PROPERTY.
- DISCUSSION OF NEW STATE LEGISLATION: THIS ITEM WAS STRUCK FROM THE AGENDA
- DISCUSSION OF A REQUEST FOR VARIANCE TO ONSITE SEWER REGULATIONS: COMMISSIONER WIMPEE REQUESTED MORE INFORMATION BEFORE ANY DISCUSSION.
- DISCUSSION OF CAD MAPPING AND COG MAPPING
- DISCUSSION OF INTERIM SPACE PLANNING: THIS ITEM WAS STRUCK FROM AGENDA.
