COMMISSIONER WIMPEE STATED THAT THE ENERGY AUDIT OF COUNTY BUILDINGS WOULD BE THIS WEEK. KAY MCDANIEL – DISTRICT CLERK STATED THAT SHE AND PART OF HER STAFF WENT TO THE RENTED STORAGE FACILITY TO DO WORK. LISA CONSTANT – COUNTY CLERK STATED THAT WITHIN THE MONTH THE COUNTY CLERK COMPUTERS WOULD HAVE THE DEED RECORD IMAGES DATING BACK TO 1978 AVAILABLE. WESLEY ROBERTS – FIRE MARSHAL DISCUSSED HIS PROPOSED FEE SCHEDULE. COMMISSIONER GRINNAN DISCUSSED HER IDEAS FOR SPACE OPTIONS.
