- DISCUSSION OF COUNTY ROAD REPAIR: PAUL MERRITT, ROAD AND BRIDGE ADMINISTRATOR REPORTED THE OVERALL ROAD DAMAGE DUE TO THE WATER PIPELINE INSTALLATION AND THE DAMAGE CAUSED BY THE RECENT DROUGHT AND SUBSEQUENT FLOODING. MR. MERRITT ADVISED THAT A CUMULATIVE REQUEST FOR DAMAGES SHOULD BE MADE TO THE NORTH CENTRAL TEXAS MUNICIPAL WATER DISTRICT FOR REPAIRS TO PORTIONS OF THE FOLLOWING COUNTY ROADS: PULLEN ROAD, WYLIE LANE, DOWELL ROAD, OLD MILLWOOD ROAD, CAMP CREEK ROAD, CLEM ROAD EXTENSION, NORTH COUNTRY LANE, GREEN CIRCLE, MACDONALD ROAD, STEVENS ROAD, CORNSTALK ROAD AND ZOLLNER ROAD.
