JUDGE FLORANCE CALLED THE WORKSHOP MEETING TO ORDER AT  
1:30PM.

**DISCUSSION OF NEW COURTHOUSE ARCHITECTURAL/CONSTRUCTION  
MANAGEMENT/PURCHASE ORDERS, AND ALL RELATED ISSUES;**

COMMISSIONER BAILEY STATED THAT THE ARCHITECTS WERE  
WORKING ON THE CHANGES TO THE SITE PLAN DUE TO COST SAVING  
EFFORTS. THE COURT DISCUSSED DETERMINING THE PHYSICAL  
ADDRESS FOR THE BUILDING AND POSSIBLY NAMING THE BUILDING THE  
ROCKWALL COUNTY COURTHOUSE INSTEAD OF REFERRING TO THE  
BUILDING AS THE JUSTICE CENTER OR THE NEW COURTHOUSE.  
FURTHER DISCUSSION INCLUDED THE DIRT AT THE SITE LOCATION AND  
COMMISSIONER BAILEY INFORMED THE COURT THAT BRUCE FIELDS OF  
MANHATTAN CONSTRUCTION WILL BE THE CONTACT FOR ANY  
QUESTIONS REGARDING THE DIRT.

**DISCUSSION OF CONTRACT ADMINISTRATION AND BID PROCESSING  
FOR THE COUNTY, AND ALL RELATED ISSUES;**

THE COURT DISCUSSED THE CENTRAL COORDINATION AND
