Government Code, Chapter 551 that the Board of Directors of River Rock Trails Municipal Utility District No. 2 f/k/a Rockwall County Water Control and Improvement District No. 2 will meet in special session, open to the public, at 12:00 p.m., on Wednesday, March 20, 2024, at 10875 John W. Elliott, Suite 400, Frisco, Texas 75033, at which meeting the following items will be considered and acted on:

1. Hear from the public;
2. Consider approving minutes of meeting of April 28, 2020;
3. Consider accepting resignation of Directors;
4. Consider appointing Directors to fill vacant positions on the Board;
5. Consider acceptance of Oaths of Office and Statements of Officer;
6. Reconstitute Officers;
7. Consider approving amended District Registration Form and authorize filing with Texas Commission on Environmental Quality;
8. Consider approving an Amended and Restated Resolution Regarding Fees of Office;
9. Hear Bookkeeper's Report and approve payment of bills;
10. Hear Developer's Report and consider taking any action required;
11. Hear Engineer's Report, including:
 - (a) authorize Engineer to proceed with the design of District facilities;
 - (b) approve plans and specifications of District facilities;
 - (c) authorize Engineer to advertise for bids for District projects;
 - (d) approval of report, pay estimates, and change orders for construction projects in progress in the District;
 - (e) authorize construction contracts and related items;
12. Consider terminating financial advisory services agreement with Robert W. Baird & Co., Inc.;
13. Consider approving financial advisory services agreement with Tierra Financial Services, LLC;
14. Hear Financial Advisor's Report and consider taking any action required;
15. Hear Attorney's Report and consider taking any action required, including:
 - (a) consider approving a Fire Protection and Emergency Medical Services Agreement by and among the City of McClendon-Chisolm, River Rock Trails Municipal Utility District No. 1, and the District;
 - (b) consider approving a Joint Fire Protection Plan by and among River Rock Trails Municipal Utility District No.1 and the District;
 - (c) consider approving a Resolution Authorizing Submission of Fire Plan to the Texas Commission on Environmental Quality;
 - (d) call hearing on exclusion of land; authorize publication of Notice of Hearing;
 - (e) consider approving an Amended and Restated Order Adopting Investment Policy;
 - (f) consider approving an Amended Notice to Sellers and Purchasers;
 - (g) consider approving an Order Designating Administrative Office and Additional Meeting Places Outside the District;
 - (h) adopt a District seal;
 - (i) ratification of a Non-Standard Water Service Agreement by and among Blackland Water Supply Corporation, Double R Land Company, LLC and the District; and
 - (j) ratification of insurance renewal proposal from McDonald & Wessendorff.
