 - (a) conducting a public hearing on exclusion of land;
 - (b) approval of Petitions for Addition of Land;
 - approval of an Order Showing Exclusions and Adding Land and Redefining the Boundaries of the District;
 - (d) approval of an Amended Notice to Sellers and Purchasers; and
 - (e) ratification of an insurance renewal proposal from McDonald & Wessendorff.

Government Code, Chapter 551, as amended, the Board of Directors may convene in closed session to receive advice from legal counsel and discuss matters relating to pending or contemplated litigation, personnel matters, real estate transactions, gifts and donations, security devices and/or economic development negotiations.
