1. Call to Order;
2. Public communication and comment;
3. Confirm receipt of Statement of Officer and Oath of Office forms from newly-elected Directors and discuss government training pursuant to Chapter 551 of the Texas Government Code;
4. Consider reorganization of Board;
5. Review and approve Minutes of April 16, 2024 Board of Directors meeting;
6. Confirm receipt of 2024 certified tax roll prepared by Rockwall Central Appraisal District, consider authorizing tax rate calculation services; adopt resolution;
7. Review tax rate recommendation, approve proposed tax rate for 2024, adopt Notice of Water District Hearing on Tax Rate, and authorize publication;
8. If timely, hear report from engineer, including authorization of advertisements for construction of additional District improvement projects as may be necessary, award construction contracts, approve pay estimates or change orders relating to on-going projects, approval and acceptance of final projects and conveyances relating to such projects, approve joint facility agreements and hear all engineering related updates and take any action as may be necessary;
9. Hear report from developer and take any action in connection with plat approval, reimbursement agreements, assignment agreements, or other development related items;
10. Review and approve bookkeeping and tax collection reports, and take any action on bookkeeping related matters including quarterly investment reports; investment recommendations; new account related matters; updated list of designated banks; revisions to engagement letter for bookkeeping services; and authorize release of checks as noted on report;
11. Discuss correspondence from City of Fate regarding District's regular Board meeting schedule, and take any action as may be necessary;
12. Discuss tentative date for next meeting; and
13. Adjournment.
