 - g. Paying Agent/Registrar Agreement;
 - Rule 15c2-12 Certificates;
 - i. Closing Certificate of President;
 - j. Tax Exemption Certificate;
 - k. IRS Form 8038-G;
 - DTC Blanket Letter of Representation;
