The Board of Directors of Rockwall County Municipal Utility District No. 10 will hold a public meeting on Friday, February 28, 2025, at 12:00 p.m., at 4514 Cole Avenue, Suite 1450, Dallas, Texas, for the following purposes, including consideration of and appropriate action on any item.

1. Public comment(s) - In accordance with the Open Meetings Act, Directors are prohibited from acting on or discussing any items brought before them at this time. Citizen's comments will be limited to 3 minutes. Comments about any of the agenda items are appreciated by the Board of Directors and may be taken into consideration at this time or during that agenda item. All remarks and questions addressed to the Board shall be addressed to the Board as a whole and not to any individual member thereof;
2. Review and approve Minutes of January 31, 2025, Board meeting;
3. Consider Developer's report, and take any related action;
4. Engineering matters, including:
 - a) Design;
 - b) Approve construction plans and specifications and authorize advertisement for bids;
 - c) Review bids and award contracts;
 - d) Approve construction invoices, pay estimates, change orders and final acceptance and direct Engineer to notify insurance company of new facilities;
 - e) Accept certificates of completion and authorize final acceptance of facilities, if necessary;
 - f) Deeds, easements, consents to encroachment, requests for service or utility commitment letters; and
 - g) Authorize and/or ratify repair and maintenance of District facilities, as necessary.
5. Review and approval of Bookkeeper's report, payment of invoices, review and approve any revised or amended operating budget, and take any other action appropriate in connection with District accounts;
6. Accept annual disclosure statements for Investment Officer and Bookkeeper;

7. Adoption of Resolution requesting preparation of District tax roll for tax year 2025;
8. Adoption of Resolution Concerning Tax Exemptions For Tax Year 2025;
9. Adopt Resolution Providing for Additional Penalty for Tax Collection;
10. Annual review of Resolution Adopting Prevailing Wage Rate Scale for Construction Projects;
11. Status of acquisition of utility easement rights;
12. Approval of proposal from Infinity Services, LLC for creation and maintenance of District website; and.
13. Discussion regarding litigation styled Rockwall County, Texas and Rockwall County Judge Frank New, Solely In His Official Capacity v. Rockwall County Municipal Utility District No. 10, et al., and take any related action; and
