Notice is hereby given pursuant to V.T.C.A., Government Code §551, that the Board of Directors of **Rockwall County Municipal Utility District No. 7** ("District") will hold a regular meeting on **Tuesday, May 20, 2025 at 5:30 p.m., at the Hampton Inn at 1549 Laguna Drive, Rockwall, Texas 75087** for the following purposes:

1. Call to order;
2. Public communications and comments;
3. Review and approve Minutes of April 15, 2025 Board of Directors Meeting;
4. Open public bids and award sale of \$1,620,000 Unlimited Tax Road Bonds, Series 2025 ("Series 2025 Road Bonds");
5. Consider approval and authorization of documents for the Series 2025 Road Bonds, including, but not limited to:
 - a. Bid awarding sale;
 - b. Bond Order;
 - c. Paying Agent/Registrar Agreement;
 - d. General and No-Litigation Certificate;
 - e. Review of representation letter to District's auditors needed to include the District's audit in the offering documents for the Series 2025 Road Bonds; and
 - f. All additional certificates and documents required to secure the necessary approval of and closing of the Series 2025 Road Bonds;
6. Consider the authorization of submission of a Transcript of Proceedings to the Texas Attorney General, confirmation of the next Board meeting date in advance of Series 2025 Road Bond closing for approval of an Agreed Upon Procedures Report, and take any action as may be necessary related thereto;
7. Hear report from engineer, including authorization of any advertisements for construction of additional District improvement projects as may be necessary; award any construction contracts, approve any pay applications or change orders relating to on-going projects and hear all engineering related updates and take any action as may be necessary;
8. Hear report from developer and take any action in connection with plat approval, reimbursement agreements or assignments thereunder, or other development related items;
9. If timely, consider review and approve Amended and Restated Reimbursement Agreement(s);

10. Review and approve bookkeeping and tax collection reports, budget, and take any action on bookkeeping related matters including quarterly investment reports; investment recommendations; new account related matters; updated list of designated banks; revisions to engagement letter for bookkeeping services; adoption of financial policies; and authorize release of checks as noted on report;
11. Discuss tentative date for next meeting; and
12. Adjourn.
