Consider approval of an Agreed Upon Procedures Report for expenditures from proceeds of the \$3,895,000 Unlimited Tax Road Bonds, Series 2025 ("Series 2025 Road Bonds"); authorize any additional action or the execution of any documents needed to close the Series 2025 Bonds; and take any action as may be necessary related thereto;
5. Consider review and approval of an Amended District Information Form; and take any action as may be necessary related thereto;
6. Hear report from engineer, including authorization of advertisements for construction of additional District improvement projects as may be necessary, award construction contracts, approve pay estimates or change orders relating to on-going projects, approval and acceptance of final projects and conveyances relating to such projects, approve joint facility agreements and hear all engineering related updates and take any action as may be necessary;
7. Hear report from developer and take any action in connection with subdivision plat approval, reimbursement agreements or assignments thereunder or other development related items;

Review and approve bookkeeping and tax collection reports, budget, and take any action on bookkeeping related matters including quarterly investment reports; investment recommendations; new account related matters; updated list of designated banks; revisions to engagement letter for bookkeeping services; adoption of financial policies; and authorize release of checks as noted on report;

10. Adjournment.
