

## Rockwall County Application for Mass Gathering Permit

All Applications must be submitted to the Rockwall County Judge by event promoters at least forty-five (45) days prior to the first day on which any event that requires a Mass Gathering Permit will be held.

No Application shall be considered to have been submitted until it is accompanied by an Application Fee. Fees shall be paid with Cashiers Check or Money Order, payable to "Rockwall County, Texas." The standard application fee for a Mass Gathering Permit is \$300.00. Special events that require more extensive review from other County officials including the Fire Marshall, the Sheriff, or the Environmental Health Department may be assessed a reasonable surcharge to compensate for the additional time spent reviewing the application and supporting materials. Applicants will be informed of any surcharges that may be assessed against an application within ten (10) business days of submitting the application and supporting materials.

Not later than the tenth (10th) day before the event for which an application is filed, the County Judge, or the County Judge's authorized designee, shall hold a public hearing to determine whether the application for a Mass Gathering Permit shall be granted. Applications may be denied for any of the reason enumerated in Section 751.007 of the Texas Health and Safety Code.

All written correspondence regarding this application shall be sent by U.S. Mail to the addresses provided by promoter on this application, unless some other method of correspondence is requested in writing by promoter or property owner.

Applicants are encouraged to review Chapter 751 of the Texas Health and Safety Code for a comprehensive perspective on Mass Gatherings and the application of Texas law to such events.
