MOTION TO DISMISS FOR COMPLIANCE

TO THE HONORABLE COURT:

The movant furnishes to the court proof of compliance and the dismissal fine or fee for the following offense:

(Check One and attached required proof of compliance):

- A *Driver's License* that was renewed, if expired, or updated with correct name and/or address, within 31 days of offense and paid a \$20 fine. TC 521.026, 521.054
- A *Driver's License or Permit* that was issued to the Defendant, appropriate for the type of vehicle operated and was valid at time of offense, and paid a \$10 administrative fee. TC 521.025-\$10 (No Driver's License)
- Removal of endorsement on *Driver's License* for (1) physical condition corrected before citation, or (2) restriction imposed in error, and paid a \$10 fine. TC 521.221
- A corrected expired *motor vehicle registration*, and paid the late registration fee to the Tax Assessor, and paid a \$20 fine. TC 502.407
- Proof the correct *motor vehicle registration insignia* was attached to the motor vehicle, establishing the vehicle was registered for the period during which the offense was committed, and paid a \$10 fine. TC 502.473 and 502.475(a)(3) (No Registration Sticker and Wrong Registration Sticker)
- Proof of proper placement of both *license plates*, and/or corrected altered or obscured plates, which plates were assigned by the Department for the period of the offense, within 31 days of the offense, and paid a \$10 fine. TC 504.943, 504.945
- Remedied an unsafe, unauthorized or prohibited *motor vehicle equipment or requirement* within 31 days of offense and paid a \$10 fine. TC 547.004 (Defective Equipment)
- Remedied expired *disabled parking placard* by renewing the placard within 31 days of the offense, and the placard was not expired more than 60 days, and paid a \$20 fine. TC 681.013
- Proof of *financial responsibility* that was valid and in effect at the time of offense and the Court verified Defendant's coverage. TC 601.193
- Proof of remedied expired vessel *certificate of number* within 10 working days of the offense, the certificate of number had not been expired for more than 60 days, and paid a \$10 fine. P&W 31.127

WHEREFORE, the movant requests that the charge be **dismissed** upon verification proof of compliance and payment of the fine as authorized by law.
